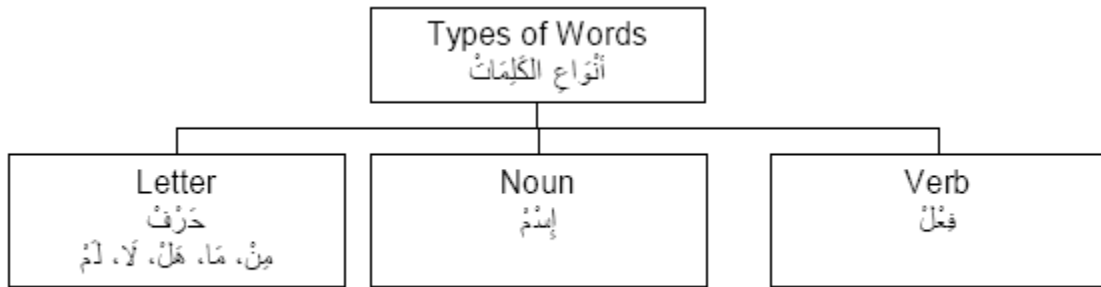
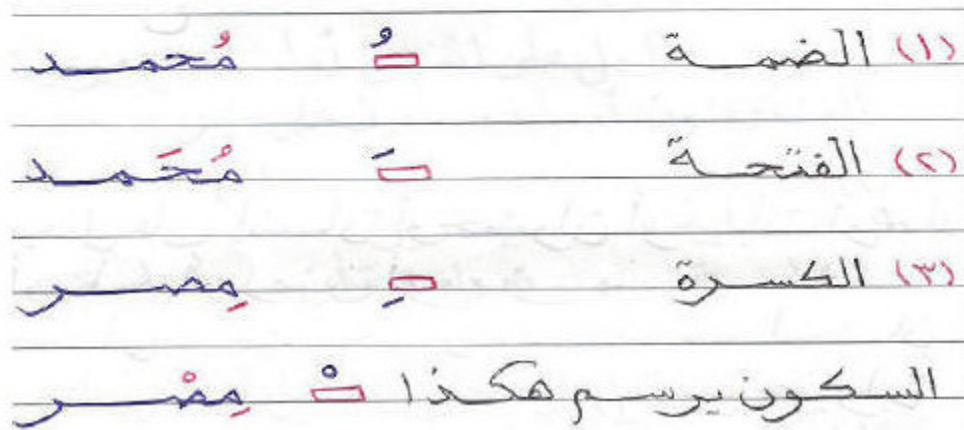


General Rules:

Rule (10): The Arabic language has the following type of words:



Rule (20): The Arabic Language has the following Sounds of letters:



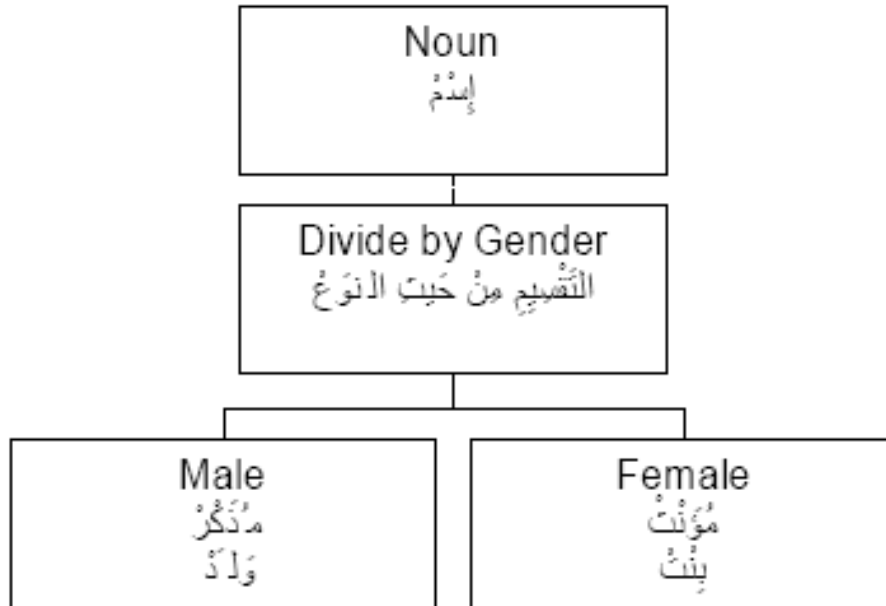
Rule (30): All Harakat can have Tanween (double Harakh) except the Sokoon.

The Noun:

Examples of Nouns

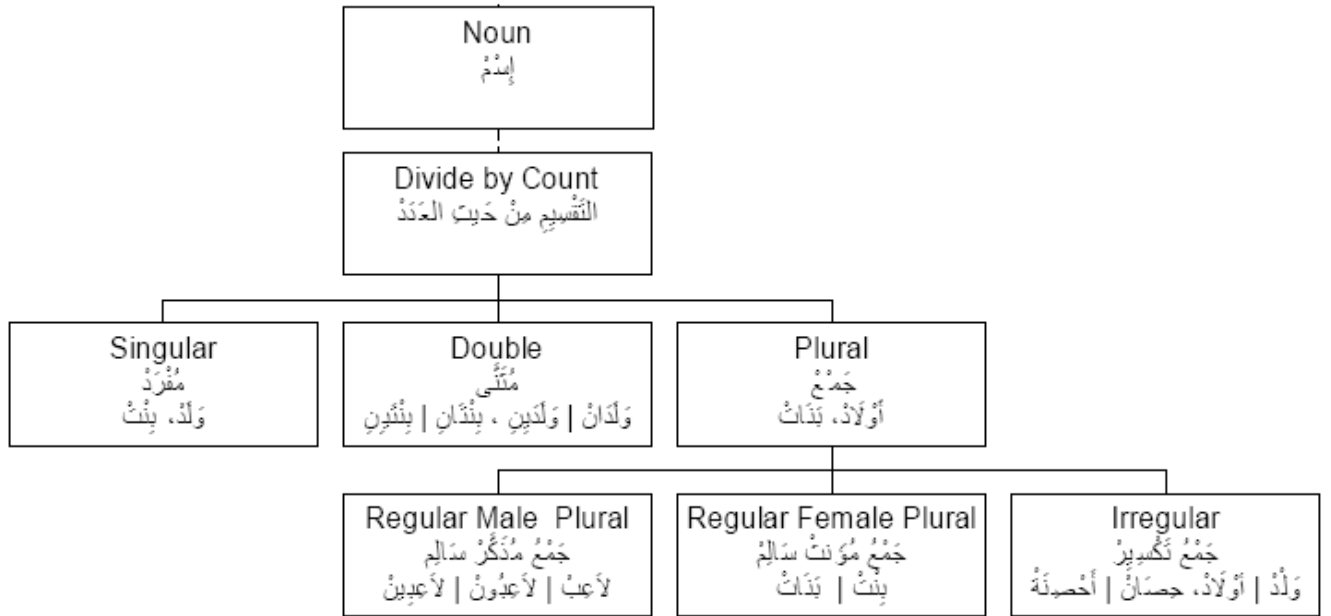
Rule (100): Nouns are divided by Gender as follows:



Rule (110) How to convert male noun to female noun.

1. The regular female nouns end with the female Ta'a (تَاءٌ)
(التَّائِيَةُ).
بِنْتُ، شَجَرَةٌ، لَاعِبَةٌ، مَدْرَسَةٌ.
2. There are other irregular female nouns that don't end with the female Ta'a.
شَمْسٌ، لَيْلَى، نَفْسٌ
3. To convert female noun into male noun, we remove the female Ta'a and vice versa.
لَاعِبَةٌ لَاعِبٌ، كَاتِبَةٌ كَاتِبٌ
4. Not all female nouns have male counterpart and vice versa.
بِنْتُ، شَجَرَةٌ، شَمْسٌ، لَيْلَى

Rule (120): Names are divided by count as follows:



1. To convert a single noun into double, you add at the end either Alif and Noon, or Ya'a and noon and vice versa. If the noun ends with Ta'a Marboota (تاء مَرْبُوطَةٌ) then it converts into open Ta'a and vice versa.

شَجْرَةٌ شَجَرَتَانِ شَجَرَتَيْنِ

2. This rule has no exceptions and it is the same for male and female.
3. When converting female noun into regular female plural, we remove the Ta'a Marboota and add Alif and Ta'a, and vice versa.

بَقْرَةٌ بَقَرَاتٌ

4. When converting male noun into regular male plural, we add Waw and Noon, Ya'a and Noon.

كَاتِبٌ كَاتِبُونَ كَاتِبِينَ

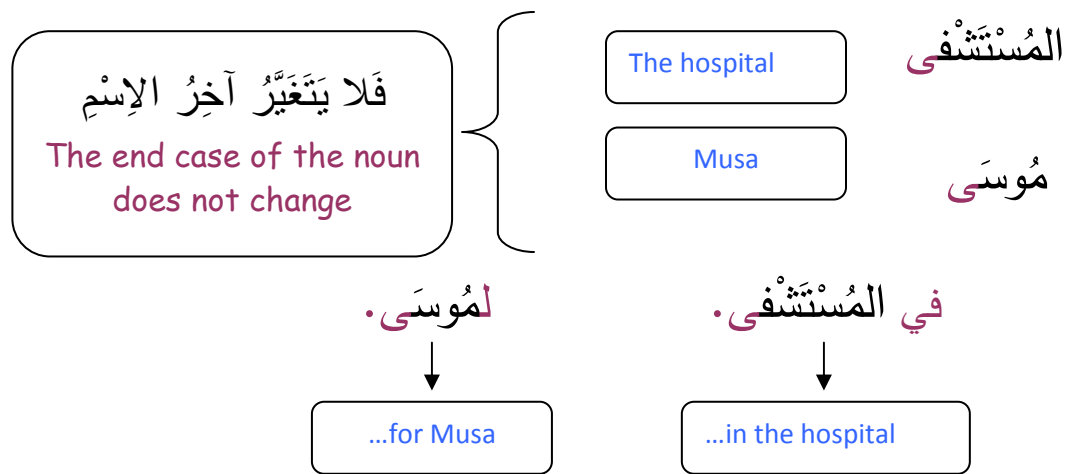
5. There are many irregular plurals. However, irregular plurals in female nouns are much less than male nouns.

شَمْسٌ شُمُوسٌ، قَلَمٌ أَقْلَامٌ، كَلْبٌ كِلَابٌ

Rule (130): The nouns ending with aa sound are called {الإِسْمُ الْمَقْصُورُ}

A noun which is ismul maqsoor, has an 'aa' sound ending. The ending vowels of these nouns remain constant, despite their change in function. If they are assigned a haraka, the Haraka is not pronounced and is called silent harakah.

أمثلة :



Rule (140): The noun will have Tanween if it doesn't have Alif Lam at the beginning.

كِتَابٌ، الْكِتَابُ بَقْرَةٌ، الْبَقْرَةُ شَرَابٌ، الشَّرَابُ

Exception is for nouns imported from other languages (non Arabic based nouns)

فِرْعَوْنٌ، مِصْرٌ، دُونَالْدُ

Rule (150): (مَرْفُوعٌ) Marfo^ form for nouns

Rule (160): (مَنْصُوبٌ) Manswob form for nouns

Rule (170): (مَجْرُورٌ) Magroor form for nouns

The Noun Sentence:

الجُمْلَةُ الاسْمِيَّةُ

Rule (300): The noun sentence starts with a noun.

Rule (310): The noun sentence is made of Subject (مُبْتَدَأٌ) and Predicate (خَبَرٌ).

The predicate (Al-Khabar) gives information about the subject (Al-Mobtada'a)

Noun Sentence = Moftada'a + Khabar

Rule (320): The default case of both Moftada'a and Khabar is Marfo[^] (مَرْفُوعٌ)

Rule (330): Exceptions to the default case: The Moftada'a is preceded by the family of Inna (إِنَّ) or the family of Kana (كَانَ).

Rule (340): If the Moftada'a is preceded by one article from the family of Inna (إِنَّ), then the Moftada'a is Mansoob and the Khabar is Marfo[^]

- The Family of Inna

إِنَّ، أَنْ، كَأَنَّ، لَكِنَّ، لَيْتَ، لَعَلَّ، لَأَ.

Rule (350): If the Moftada'a is preceded by one article from the family of Kana (كَانَ), then the Moftada'a is Marfo[^] and the Khabar is Mansoob.

- The Family of Kana

كَانَ، يَكُونُ، كُنْ، أَصْبَحَ، يُصْبِحُ، أَصْبَحَ، أَضْحَى، يَضْحَى،
أَضْحَ، أَمْسَى، يُمْسِي، أَمْسَ، بَاتَ، يَبِيتُ، بَيْتَ، ظَلَّ، يَظِلُّ، ظَلَّ،
صَارَ، يَصِيرُ، صِرَّ.

Rule (360): Both the noun and the adjective must agree in gender and count.

Adding Two Nouns

المُضَافُ وَالمُضَافُ إِلَيْهِ

Rule (400): It is equivalent to *X of Y* or *Y's X* in English.

Example: The car of the neighbor, or the neighbor's car. سَيَّارَةُ الْجَارِ

Rule (410): The first noun is called Modaf (المُضَافُ) and the second noun is Modaf Ilayh (والمُضَافُ إِلَيْهِ).

Rule (420): The first noun (المُضَافُ) can't have Tanween (تَنْوِينٌ).

Rule (430): The second noun (المُضَافُ إِلَيْهِ) is always Magroor (مَجْرُورٌ).

Adjective and Its Noun

الصِّفَةُ وَالمَوْصُوفُ

Rule (500): Unlike the English language, the noun comes first and the adjective comes second.

Rule (510): Both the noun and the adjective must agree in gender and count.

Rule (520): If the noun has Tanween (تَنْوِينٌ) then the adjective must have Tanween as well.

Rule (530): If the noun has Alif-Lam (أَلِفٌ لَامٌ) then the adjective must have Alif-Lam as well.

Prepositions

حُرُوفُ الْجَرِّ

Prepositions	Examples of Prepositions / usage
in فِي	in a house فِي بَيْتٍ
from مِنْ	We read from the Qur'an. قَرَأْنَا مِنَ الْقُرْآنِ
on عَلَى	on a mountain عَلَى جَبَلٍ

Rule 500: They come before nouns. They are used as connectors.

Rule 510: The noun after the preposition must be Majroor مَجْرُورٌ.

Rule 520: The reason they are called (حُرُوفُ الْجَرِّ) because the noun that follows them must be Majroor مَجْرُورٌ.

The Verb Sentence:

الْجُمْلَةُ الْفِعْلِيَّةُ

Rule (600): The verb sentence starts with a verb.

Rule (610): The verb sentence is made of the following

فِعْلٌ + فَاعِلٌ + مَفْعُولٌ بِهِ

[or]

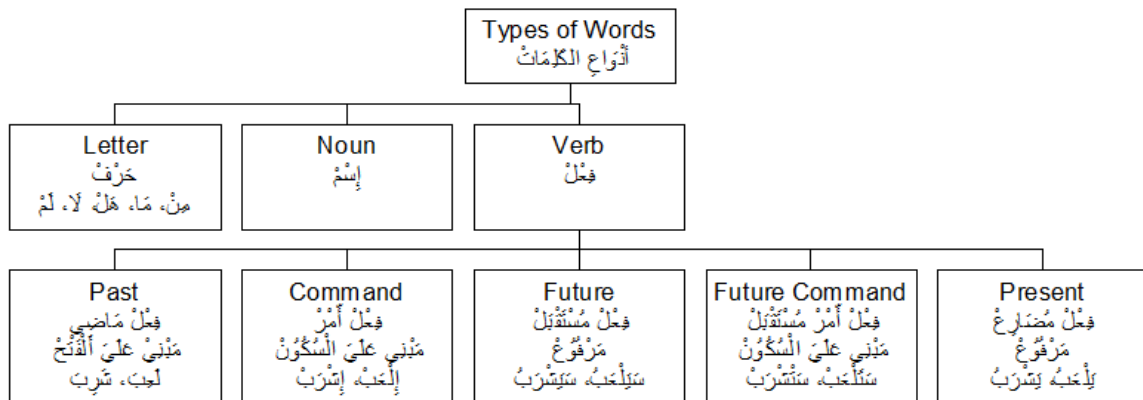
فِعْلٌ + مَفْعُولٌ بِهِ + فَاعِلٌ

Rule (620): The subject is either a noun or pronoun and it is always Marbo[^] (مَرْفُوعٌ)

Rule (630): The object is either a noun or pronoun and it is always Mansoob (مَنْصُوبٌ)

Rule (640): Both the subject and object can be nouns or pronouns. You can tell the difference between them by determining which one is Marfo[^] and which one is Mansoob.

Rule (650): The verb can be either one of the following:

Rule 700 is the table.

Notes:

1. 2M and 2F are always the same.
2. The first person has only two cases; singular and plural.

Rule 710: The past tense verb grammar is always Fatha, no exceptions, i.e. مَبْنِي عَلَى الْفَتْحَةِ

Rule 720: The ن in the 3+F is called Noon Al-Niwah or Women Noon النِسْوَةُ

Rule 730: The Alif at the end of the 2M and 2F is called Alif Al-Mothana or Alif of Double أَلِفُ الْمُتَنَّى

Rule 740: The نَا at the end of 1st person 2M, 3+M, 3F and 3+F is called Na of multiple doers

نَا الدَّالَّةُ عَلَى الْفَاعِلِينَ

Rule 820: The default case of the present tense verb is Marfoo^

Reminders:

1. The subject noun default case is Marfoo^
2. The object noun default case is Mansoob.

Rule 920: The dos and don't are Magzoom with Sokoon

Reminders:

1. Note that for verbs we have Marfoo[^] with Damah, Mansoob with Fatha , Majroor with Kasra, and Magzoom with Sokoon.
2. The subject is always "you".
3. The object noun default case is Mansoob.

Rule 1020:

The future tense is made by attaching the Seen “س” letter to the beginning of the present tense verb.

Reminders 1030:

1. Note that for verbs we have Marfoo^ with Damah, Mansoob with Fatha , Majroor with Kasra, and Magzoom with Skoon.
2. The subject here is always a pronoun.
3. The object noun default case is Mansoob.
